



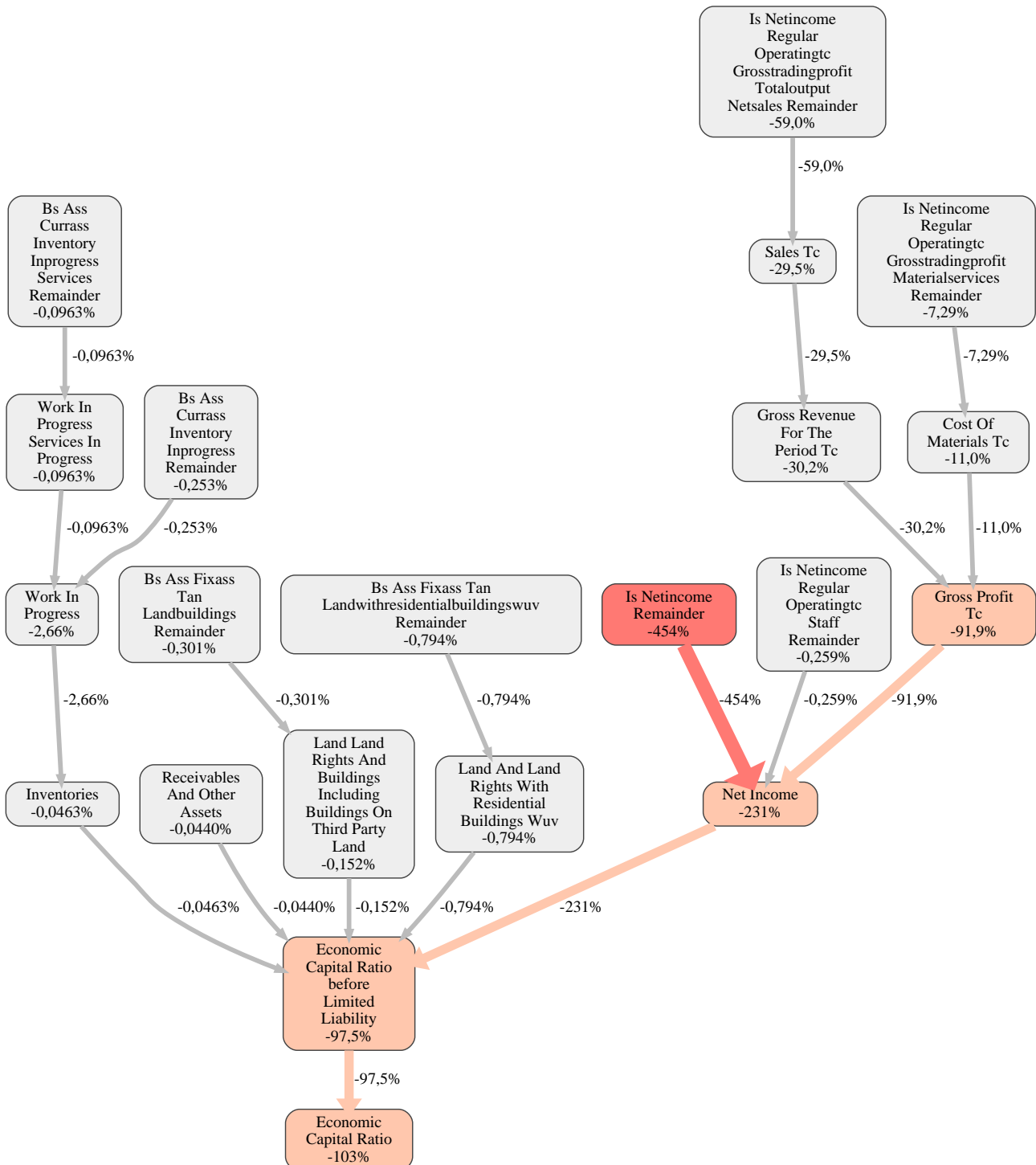

The greatest strength of wb Service GmbH compared to the market average is the variable Bs Ass Currass Cashequiv Remainder, increasing the Economic Capital Ratio by 0,013% points. The greatest weakness of wb Service GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 454% points.

The company's Economic Capital Ratio, given in the ranking table, is 0,013%, being 103% points below the market average of 103%.
