



The relative strengths and weaknesses of IWS Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of IWS Bau GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 193% points. The greatest weakness of IWS Bau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 286% points.

The company's Economic Capital Ratio, given in the ranking table, is 204%, being 101% points above the market average of 103%.
