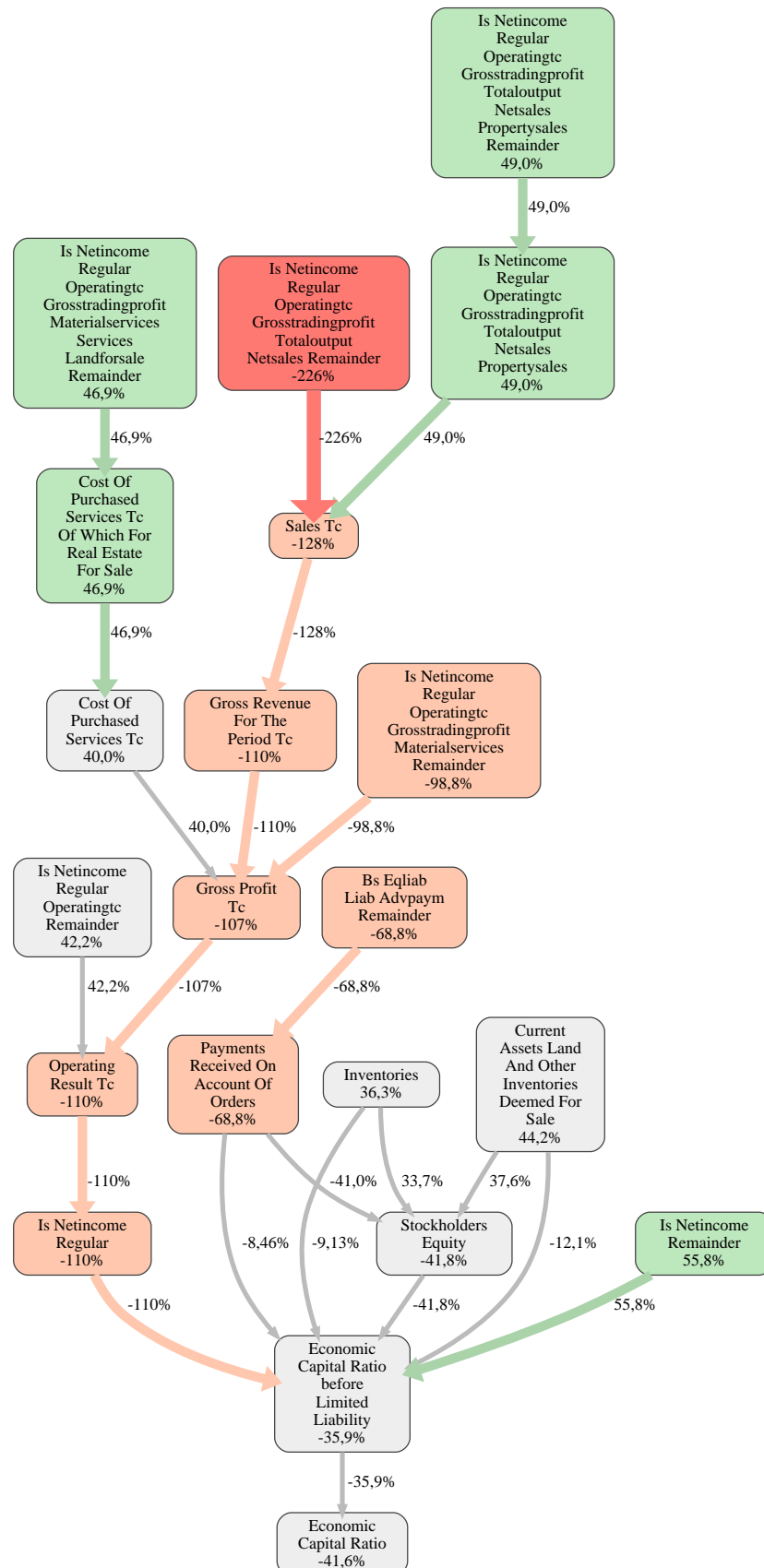

The relative strengths and weaknesses of Paeschke Bauträger GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Paeschke Bauträger GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 56% points. The greatest weakness of Paeschke Bauträger GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, reducing the Economic Capital Ratio by 226% points.

The company's Economic Capital Ratio, given in the ranking table, is 62%, being 42% points below the market average of 103%.
