



The relative strengths and weaknesses of F K HORN GmbH Co KG Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of F K HORN GmbH Co KG Bauunternehmung compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 132% points. The greatest weakness of F K HORN GmbH Co KG Bauunternehmung is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 554% points.

The company's Economic Capital Ratio, given in the ranking table, is 132%, being 29% points above the market average of 103%.
