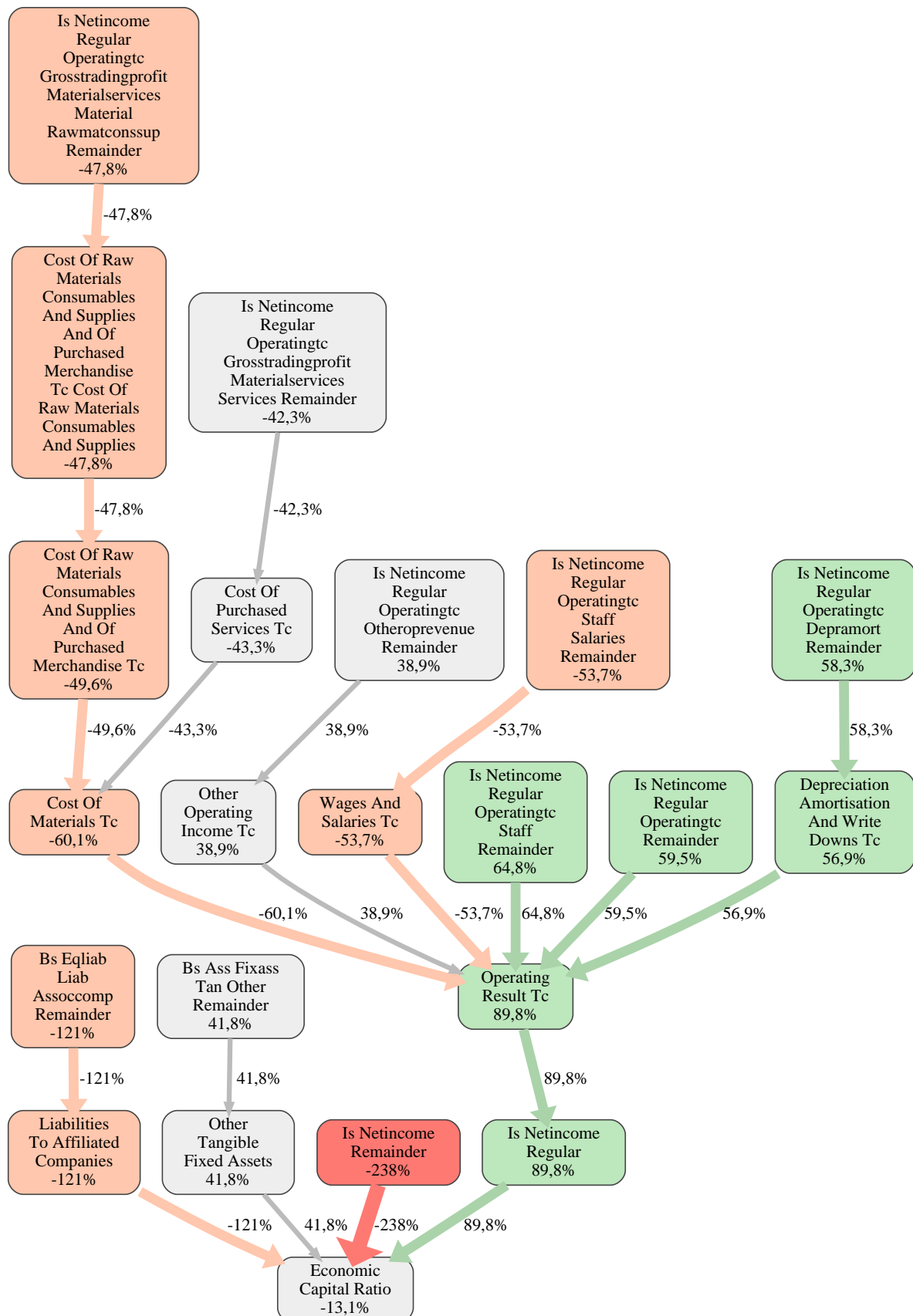

The relative strengths and weaknesses of Implenla Schalungsbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Implenla Schalungsbau GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 90% points. The greatest weakness of Implenla Schalungsbau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 238% points.

The company's Economic Capital Ratio, given in the ranking table, is 90%, being 13% points below the market average of 103%.
