The greatest strength of Bauwerke Bauträger GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 58% points. The greatest weakness of Bauwerke Bauträger GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 198% points.

The company's Economic Capital Ratio, given in the ranking table, is 58%, being 45% points below the market average of 103%.
