



The relative strengths and weaknesses of RBI Raiffeisen Bauträger u Immobilien GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of RBI Raiffeisen Bauträger u Immobilien GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Remainder, increasing the Economic Capital Ratio by 65% points. The greatest weakness of RBI Raiffeisen Bauträger u Immobilien GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 558% points.

The company's Economic Capital Ratio, given in the ranking table, is 65%, being 38% points below the market average of 103%.
