



The relative strengths and weaknesses of Guggenberger GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Guggenberger GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 169% points. The greatest weakness of Guggenberger GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 288% points.

The company's Economic Capital Ratio, given in the ranking table, is 173%, being 70% points above the market average of 103%.
