



The relative strengths and weaknesses of Implenla Deutschland GmbH Vormal's Implenla Holding GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Implenla Deutschland GmbH Vormal's Implenla Holding GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 49% points. The greatest weakness of Implenla Deutschland GmbH Vormal's Implenla Holding GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 351% points.

The company's Economic Capital Ratio, given in the ranking table, is 49%, being 54% points below the market average of 103%.
