

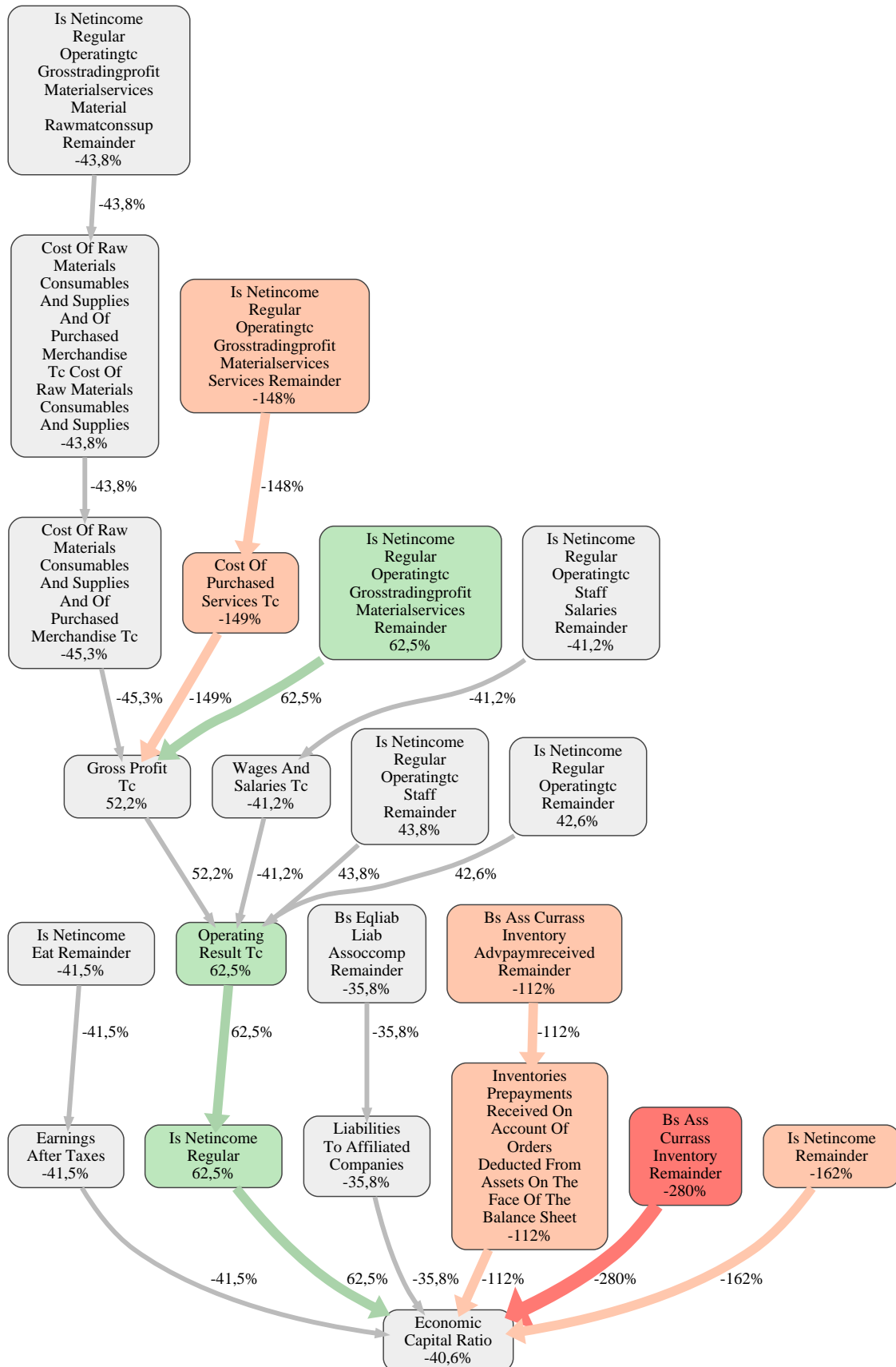

The greatest strength of Implenia Civil Engineering GmbH Vormals Implenia Construction GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 63% points. The greatest weakness of Implenia Civil Engineering GmbH Vormals Implenia Construction GmbH is the variable Bs Ass Currass Inventory Remainder, reducing the Economic Capital Ratio by 280% points.

The company's Economic Capital Ratio, given in the ranking table, is 63%, being 41% points below the market average of 103%.
