



The relative strengths and weaknesses of Grötz GmbH Co KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Grötz GmbH Co KG Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 114% points. The greatest weakness of Grötz GmbH Co KG Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 704% points.

The company's Economic Capital Ratio, given in the ranking table, is 114%, being 11% points above the market average of 103%.
