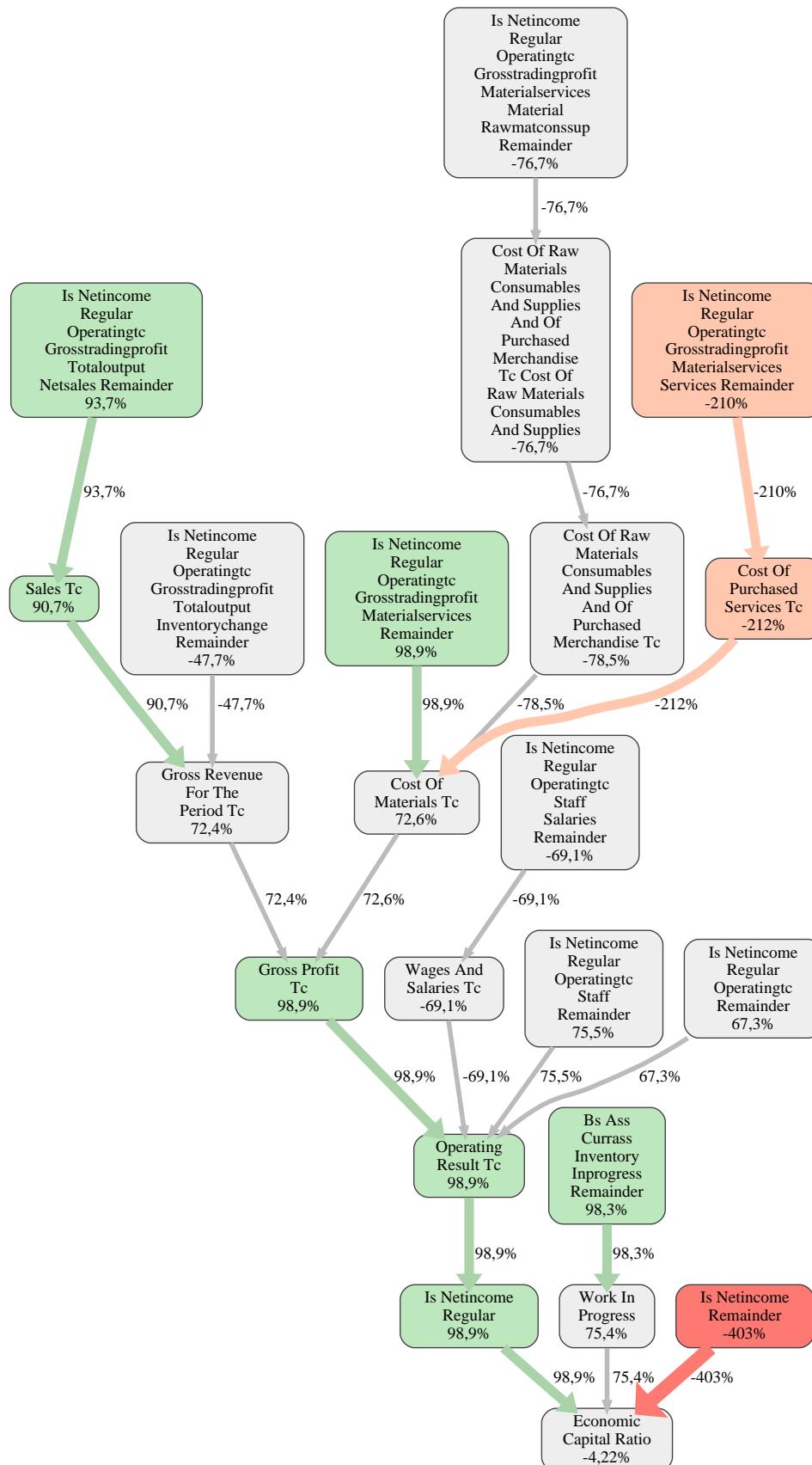

The relative strengths and weaknesses of Heberger GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Heberger GmbH Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 99% points. The greatest weakness of Heberger GmbH Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 403% points.

The company's Economic Capital Ratio, given in the ranking table, is 99%, being 4,2% points below the market average of 103%.
