

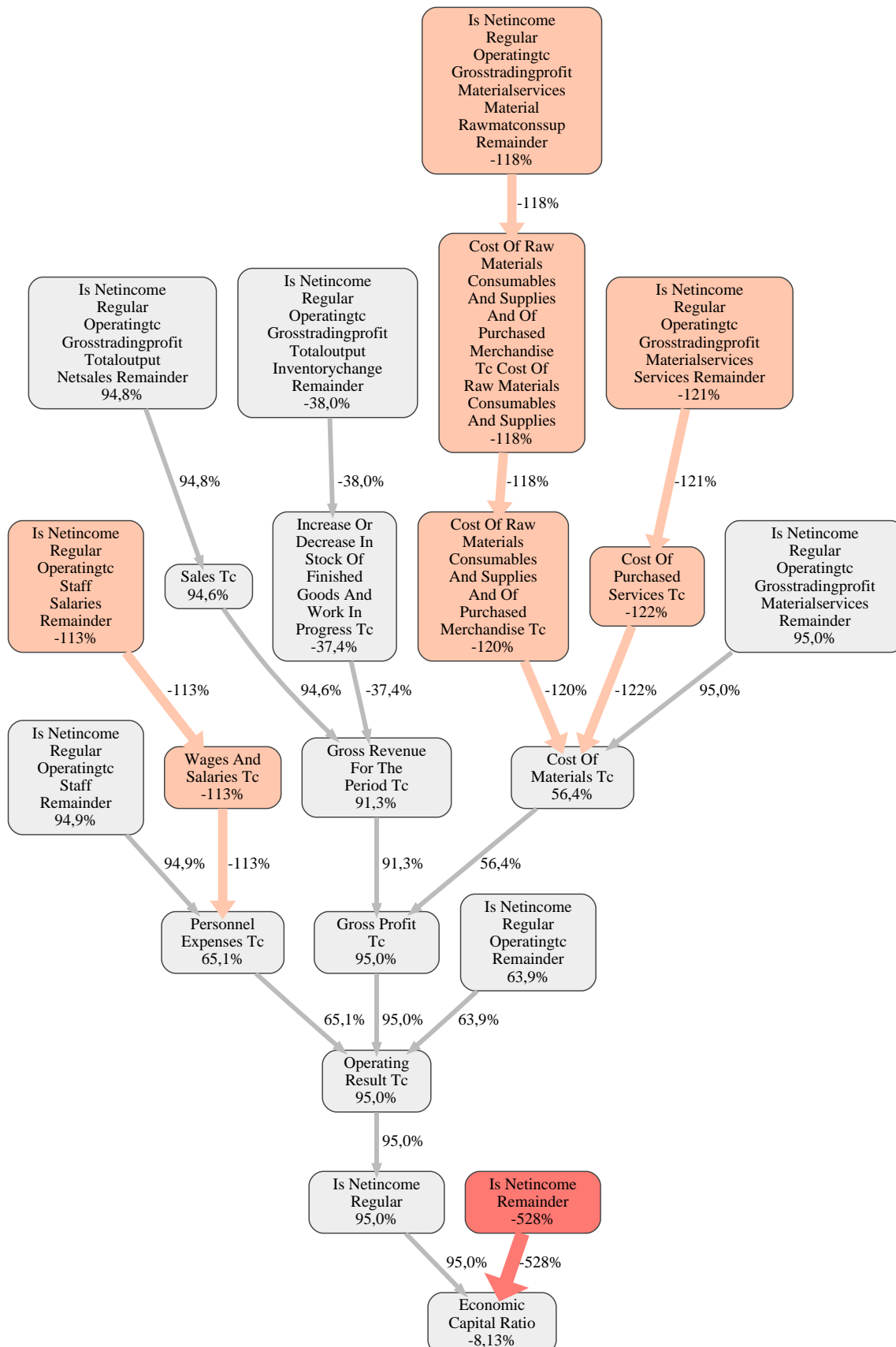

The relative strengths and weaknesses of Backes AG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Backes AG Konzern compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 95% points. The greatest weakness of Backes AG Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 528% points.

The company's Economic Capital Ratio, given in the ranking table, is 95%, being 8,1% points below the market average of 103%.
