



The relative strengths and weaknesses of Pfaffinger Verwaltungs GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Pfaffinger Verwaltungs GmbH Konzern compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 151% points. The greatest weakness of Pfaffinger Verwaltungs GmbH Konzern is the variable Is Netincome Regular Remainder, reducing the Economic Capital Ratio by 898% points.

The company's Economic Capital Ratio, given in the ranking table, is 151%, being 48% points above the market average of 103%.
