



The relative strengths and weaknesses of Anton Meyer GmbH Co KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Anton Meyer GmbH Co KG Konzern compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 110% points. The greatest weakness of Anton Meyer GmbH Co KG Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 252% points.

The company's Economic Capital Ratio, given in the ranking table, is 111%, being 7,9% points above the market average of 103%.
