

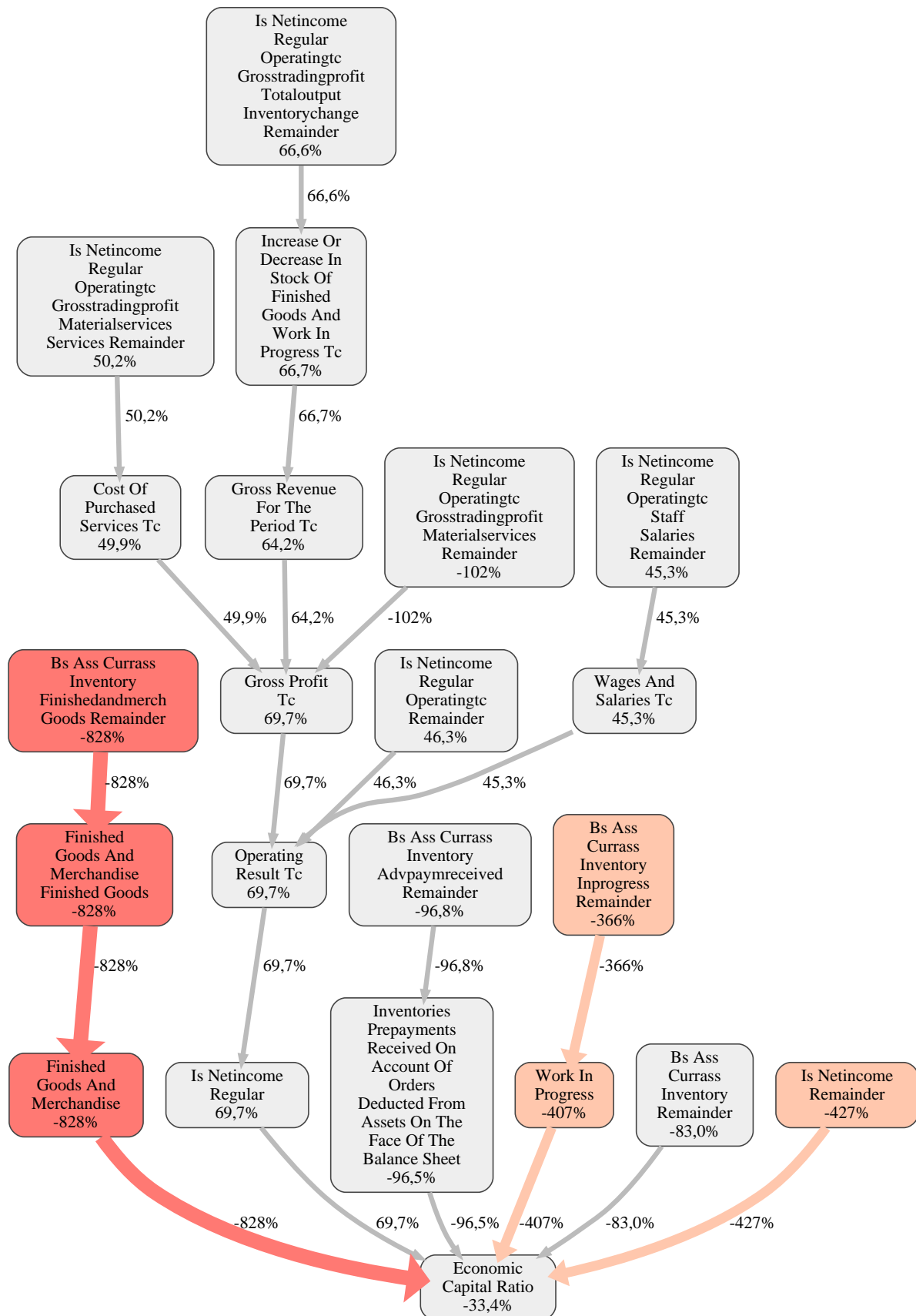

The relative strengths and weaknesses of Himmel u Papesch Bauunternehmung GmbH Co KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Himmel u Papesch Bauunternehmung GmbH Co KG Konzern compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 70% points. The greatest weakness of Himmel u Papesch Bauunternehmung GmbH Co KG Konzern is the variable Finished Goods And Merchandise, reducing the Economic Capital Ratio by 828% points.

The company's Economic Capital Ratio, given in the ranking table, is 70%, being 33% points below the market average of 103%.
