The greatest strength of BGW Bielefelder Gesellschaft für Wohnen und Immobiliendienstleistungen mbH Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 64% points. The greatest weakness of BGW Bielefelder Gesellschaft für Wohnen und Immobiliendienstleistungen mbH Konzern is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 322% points.

The company's Economic Capital Ratio, given in the ranking table, is 64%, being 39% points below the market average of 103%.
