

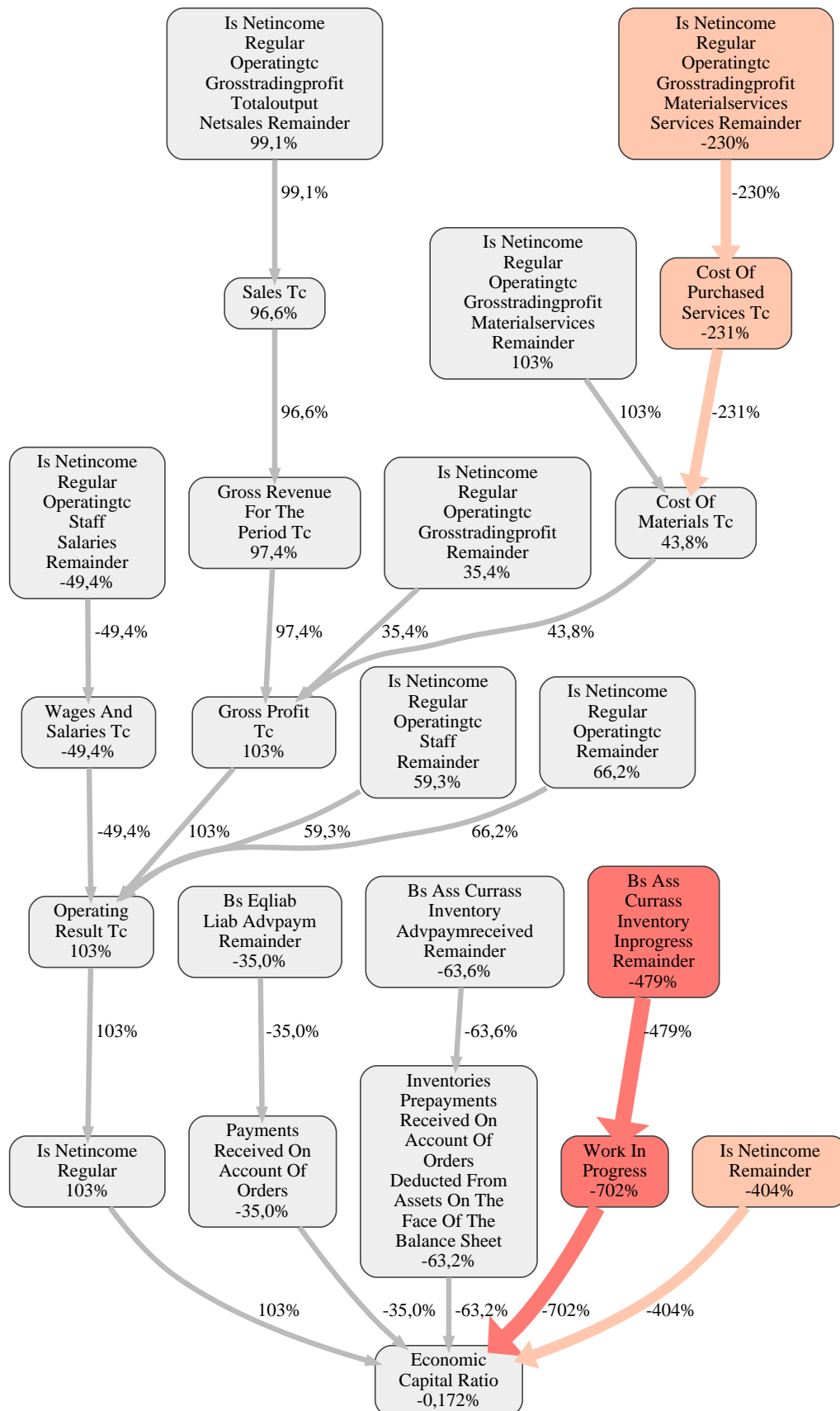

The relative strengths and weaknesses of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG Konzern compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 103% points. The greatest weakness of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG Konzern is the variable Work In Progress, reducing the Economic Capital Ratio by 702% points.

The company's Economic Capital Ratio, given in the ranking table, is 103%, being 0,17% points below the market average of 103%.
