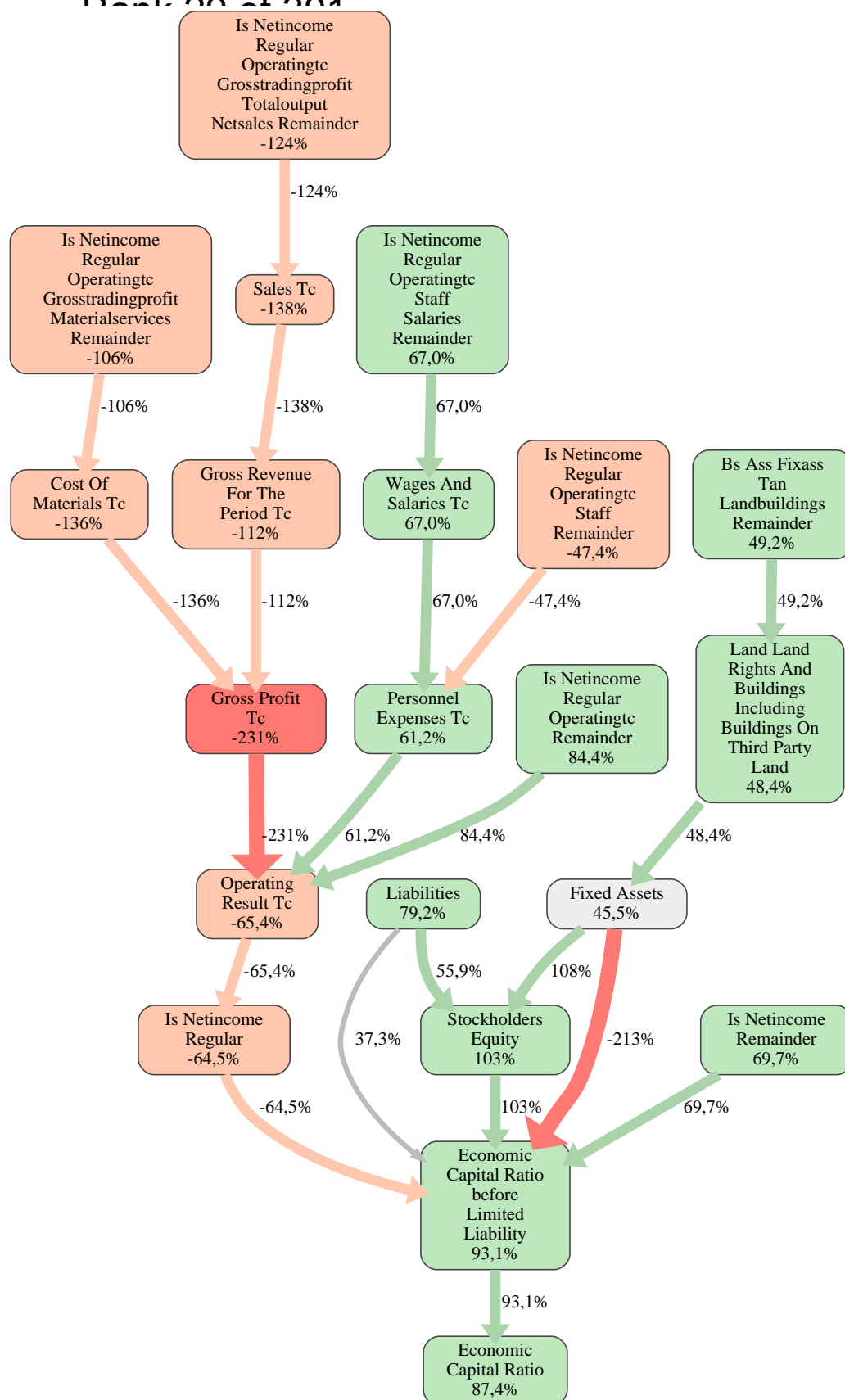

We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Lebenshilfe Bayern Mitte GmbH Vormals Lebenshilfe Werkstätten der Region 10 Gesellschaft mit Beschränkter Haftung compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 103% points. The greatest weakness of Lebenshilfe Bayern Mitte GmbH Vormals Lebenshilfe Werkstätten der Region 10 Gesellschaft mit Beschränkter Haftung is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 231% points.

The company's Economic Capital Ratio, given in the ranking table, is 191%, being 87% points above the market average of 103%.
