



The relative strengths and weaknesses of Wohnbau GmbH Wolfstein are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnbau GmbH Wolfstein compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 73% points. The greatest weakness of Wohnbau GmbH Wolfstein is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 361% points.

The company's Economic Capital Ratio, given in the ranking table, is 73%, being 30% points below the market average of 103%.
