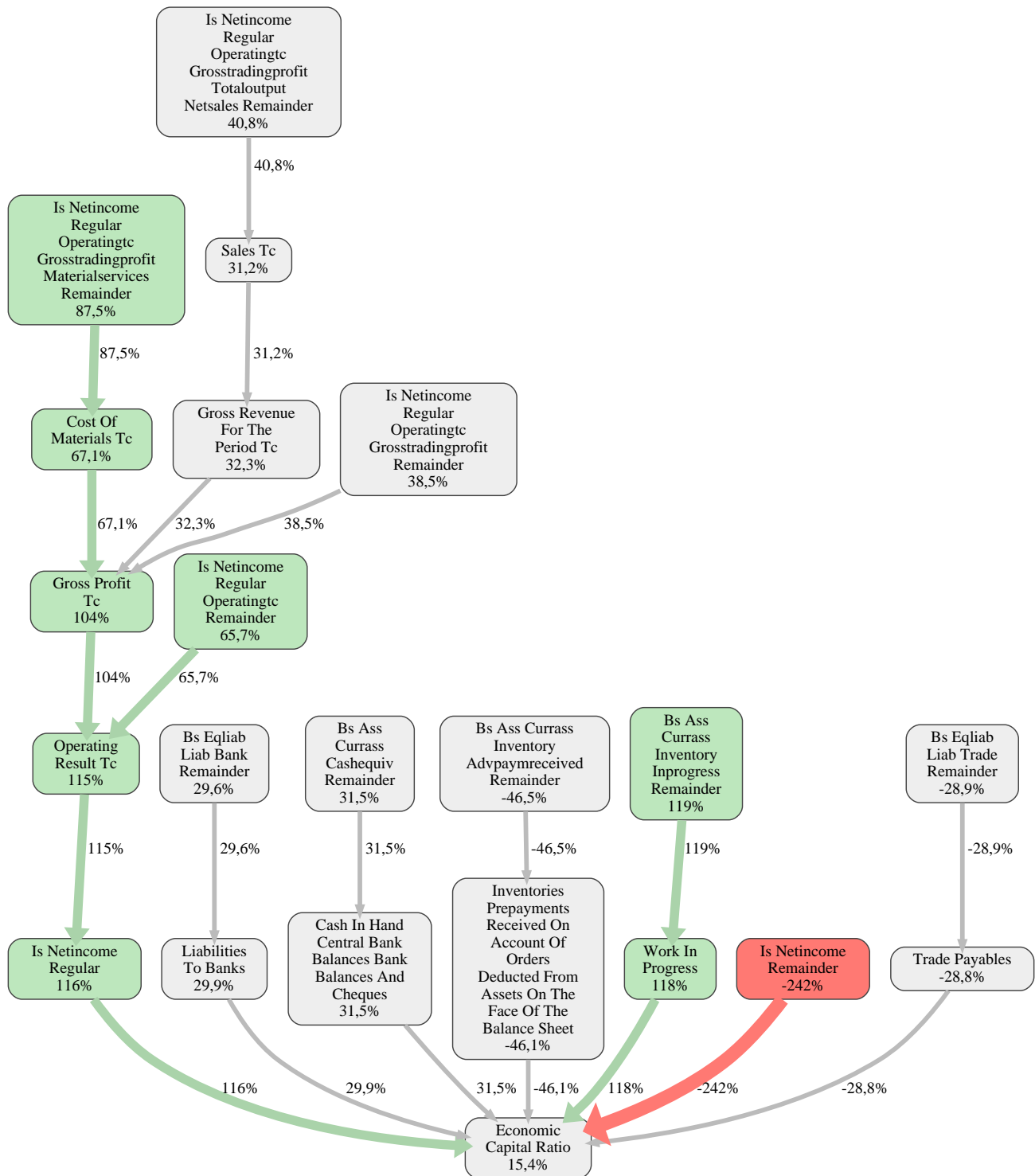

The relative strengths and weaknesses of MBN GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MBN GmbH Konzern compared to the market average is the variable Bs Ass Currass Inventory Inprogress Remainder, increasing the Economic Capital Ratio by 119% points. The greatest weakness of MBN GmbH Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 242% points.

The company's Economic Capital Ratio, given in the ranking table, is 119%, being 15% points above the market average of 103%.
