The greatest strength of Derichs u Konertz GmbH u Co KG compared to the market average is the variable Bs Ass Currass Inventory Inprogress Remainder, increasing the Economic Capital Ratio by 85% points. The greatest weakness of Derichs u Konertz GmbH u Co KG is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 406% points.

The company's Economic Capital Ratio, given in the ranking table, is 85%, being 19% points below the market average of 104%.
