

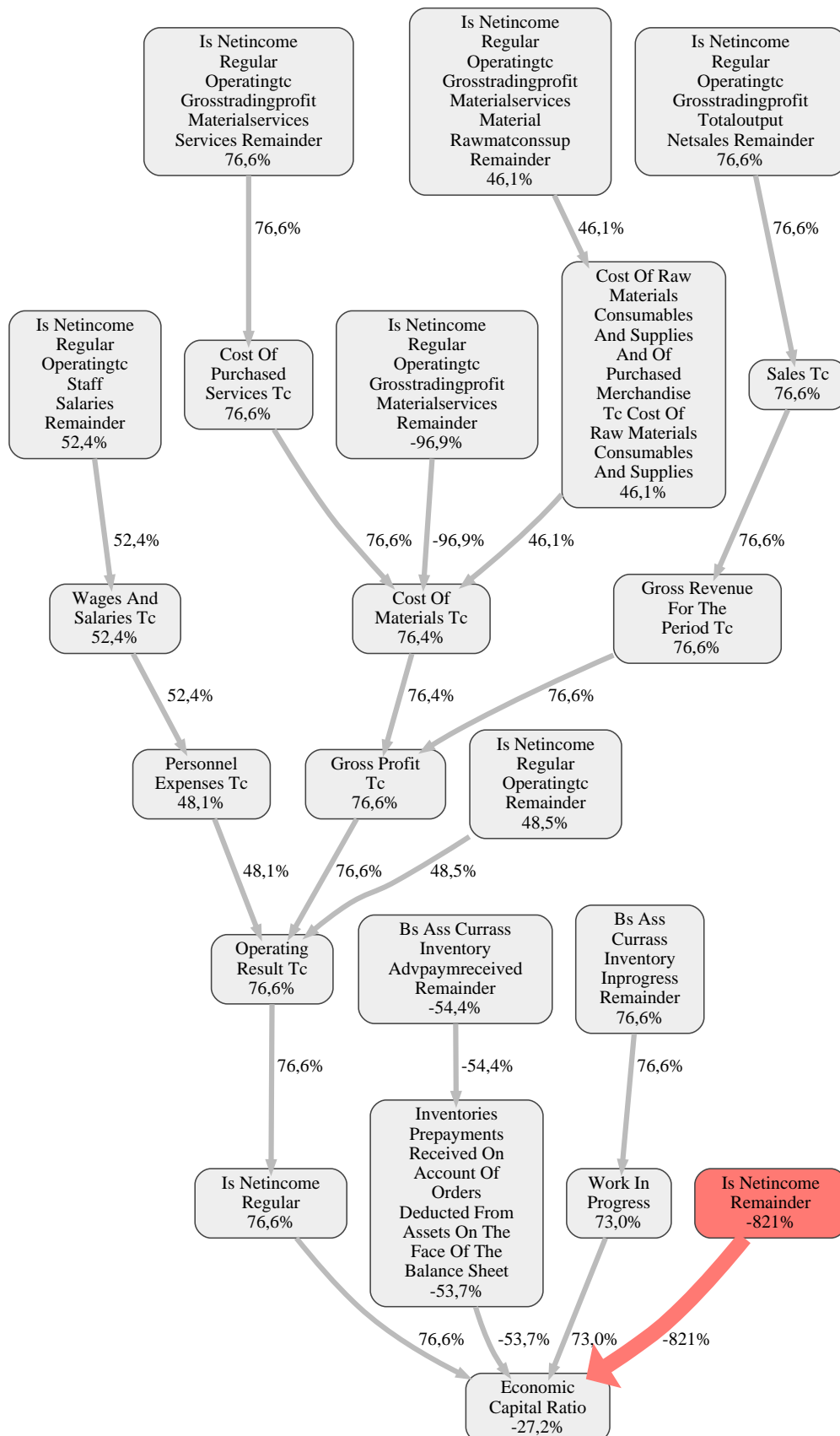

The relative strengths and weaknesses of Lambert Schlun GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Lambert Schlun GmbH Co KG compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 77% points. The greatest weakness of Lambert Schlun GmbH Co KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 821% points.

The company's Economic Capital Ratio, given in the ranking table, is 77%, being 27% points below the market average of 104%.
