

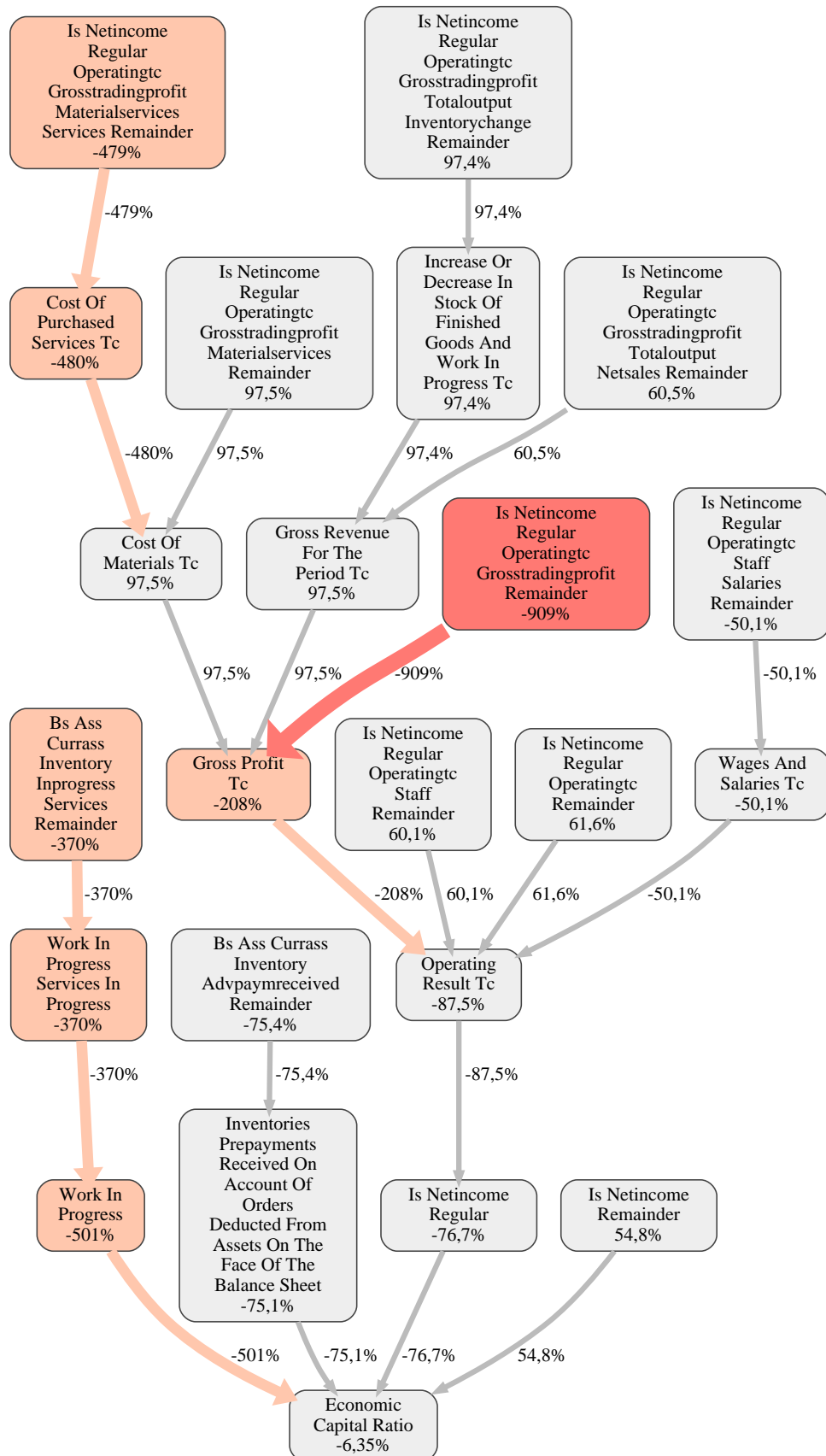

The greatest strength of Nesslerer bau gmbh compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 98% points. The greatest weakness of Nesslerer bau gmbh is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 909% points.

The company's Economic Capital Ratio, given in the ranking table, is 98%, being 6,3% points below the market average of 104%.
