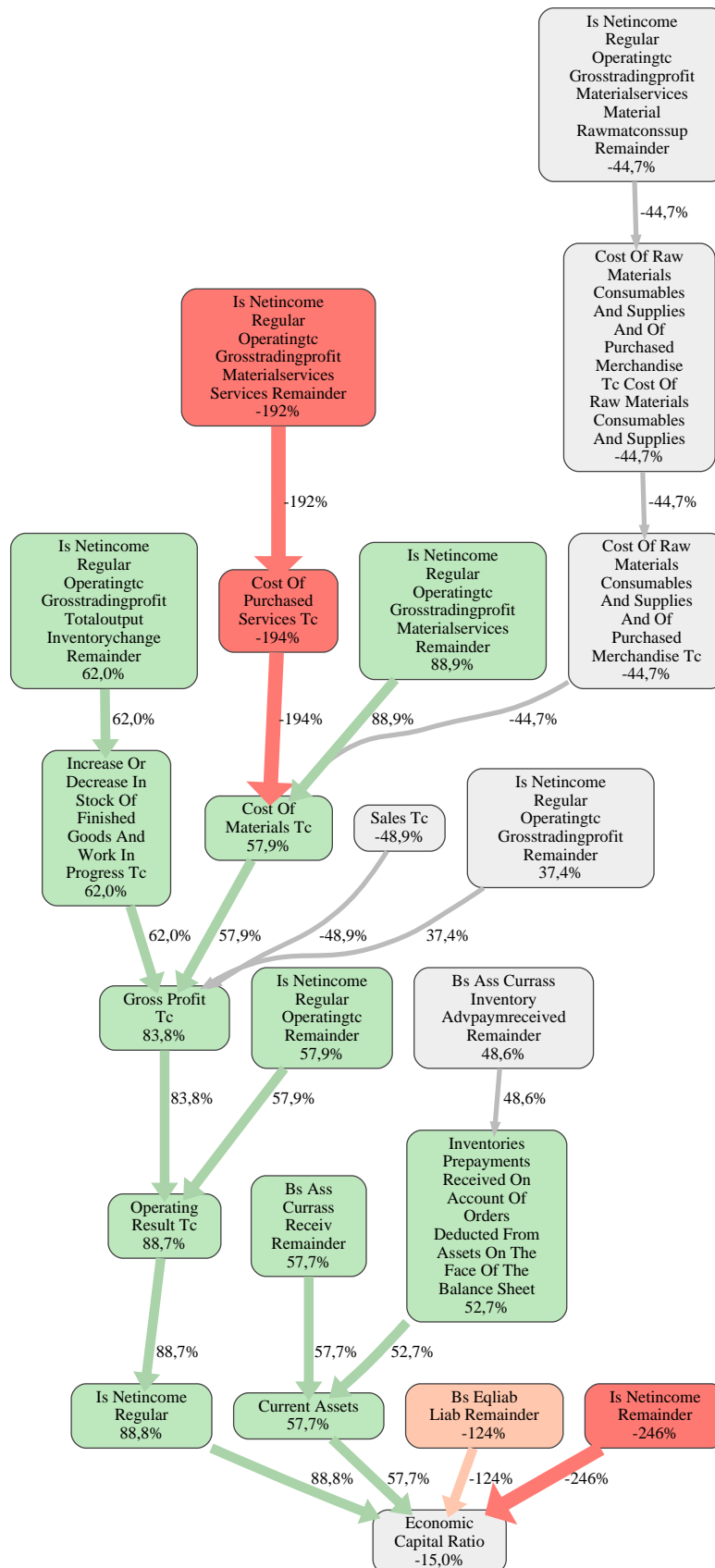

The greatest strength of E L I A Bau Projektmanagement GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 89% points. The greatest weakness of E L I A Bau Projektmanagement GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 246% points.

The company's Economic Capital Ratio, given in the ranking table, is 89%, being 15% points below the market average of 104%.
