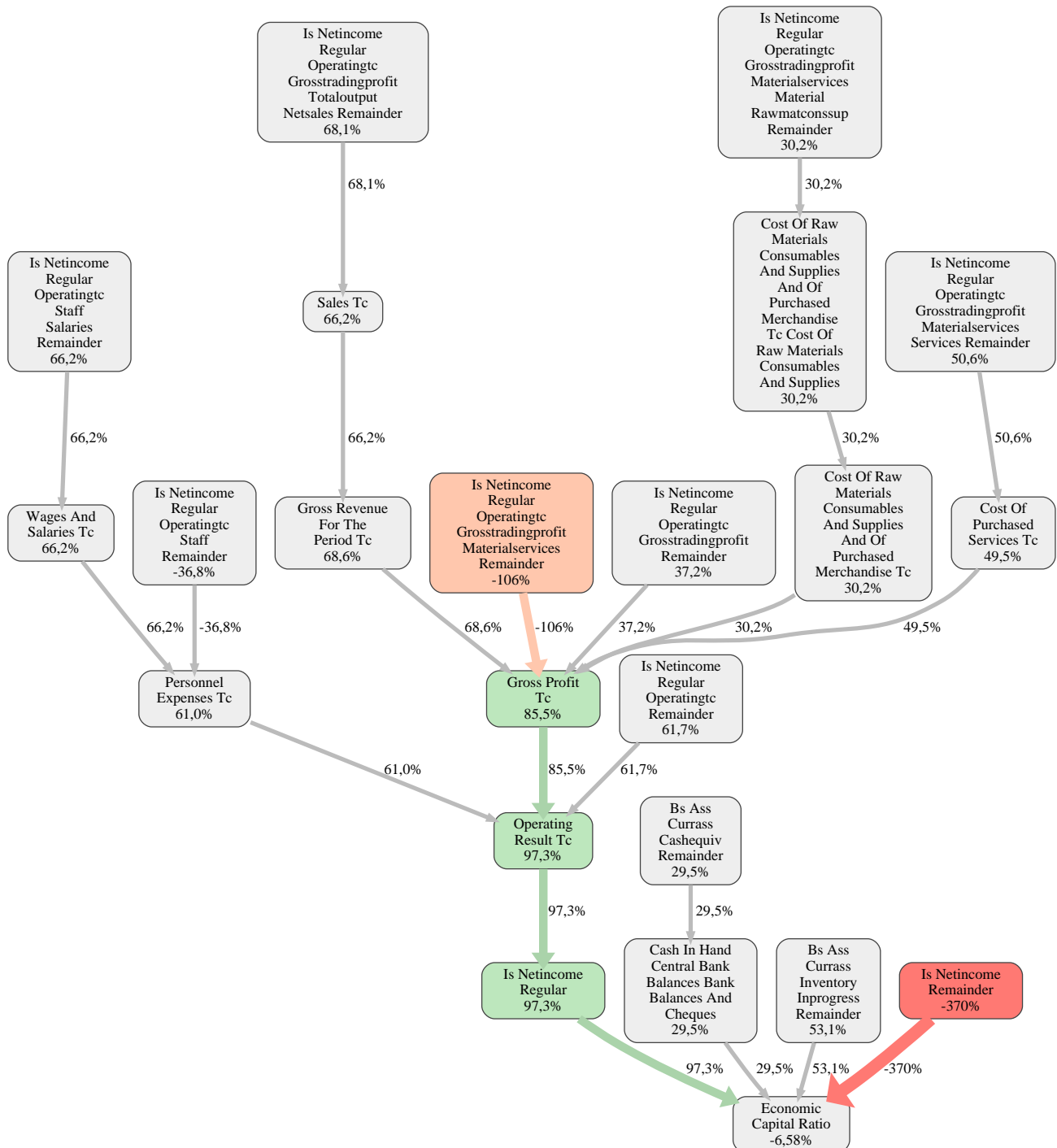

The greatest strength of Gunter Hüttner Co GmbH Bauunternehmung compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 97% points. The greatest weakness of Gunter Hüttner Co GmbH Bauunternehmung is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 370% points.

The company's Economic Capital Ratio, given in the ranking table, is 97%, being 6,6% points below the market average of 104%.
