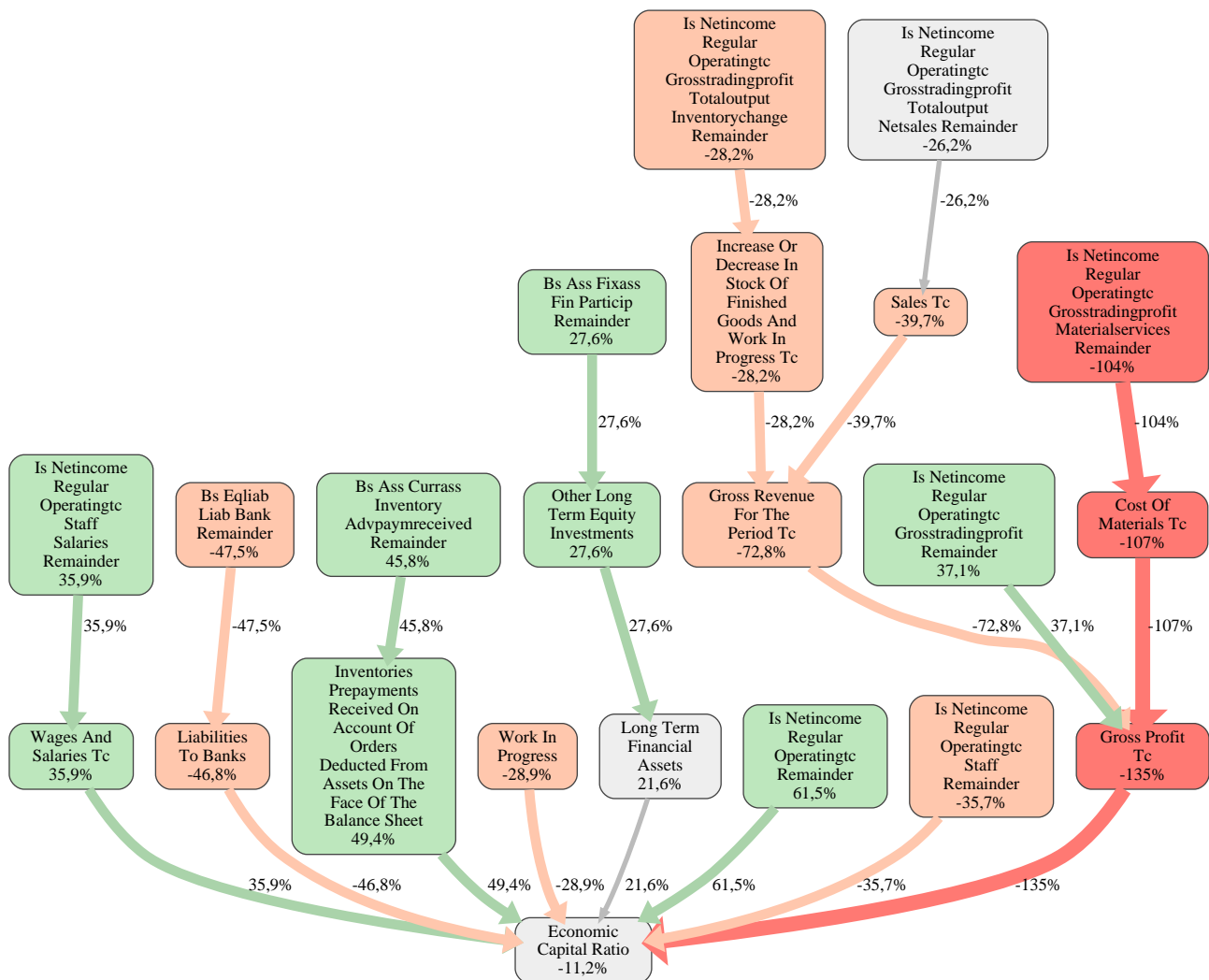

The greatest strength of Krüger Hochbau GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Remainder, increasing the Economic Capital Ratio by 61% points. The greatest weakness of Krüger Hochbau GmbH Co KG is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 135% points.

The company's Economic Capital Ratio, given in the ranking table, is 93%, being 11% points below the market average of 104%.
