



The relative strengths and weaknesses of Krüger Bau Bernau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Krüger Bau Bernau GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 57% points. The greatest weakness of Krüger Bau Bernau GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 297% points.

The company's Economic Capital Ratio, given in the ranking table, is 57%, being 47% points below the market average of 104%.
