The greatest strength of Peter Ahrens Bauunternehmen GmbH compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 67% points. The greatest weakness of Peter Ahrens Bauunternehmen GmbH is the variable Bs Ass Currass Inventory Inprogress Services Remainder, reducing the Economic Capital Ratio by 3.982% points.

The company's Economic Capital Ratio, given in the ranking table, is 67%, being 36% points below the market average of 104%.
