



The relative strengths and weaknesses of Wadle Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wadle Bauunternehmung GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 91% points. The greatest weakness of Wadle Bauunternehmung GmbH is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 818% points.

The company's Economic Capital Ratio, given in the ranking table, is 91%, being 13% points below the market average of 104%.
