



The relative strengths and weaknesses of Rolf Bau Hoch und Tiefbau Zweigniederlassung der Fa Rolf Bau are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Rolf Bau Hoch und Tiefbau Zweigniederlassung der Fa Rolf Bau compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 234% points. The greatest weakness of Rolf Bau Hoch und Tiefbau Zweigniederlassung der Fa Rolf Bau is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 571% points.

The company's Economic Capital Ratio, given in the ranking table, is 234%, being 130% points above the market average of 104%.
