



The relative strengths and weaknesses of Brunner Co Baugesellschaft mbH Co München are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Brunner Co Baugesellschaft mbH Co München compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 68% points. The greatest weakness of Brunner Co Baugesellschaft mbH Co München is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 609% points.

The company's Economic Capital Ratio, given in the ranking table, is 68%, being 36% points below the market average of 104%.
