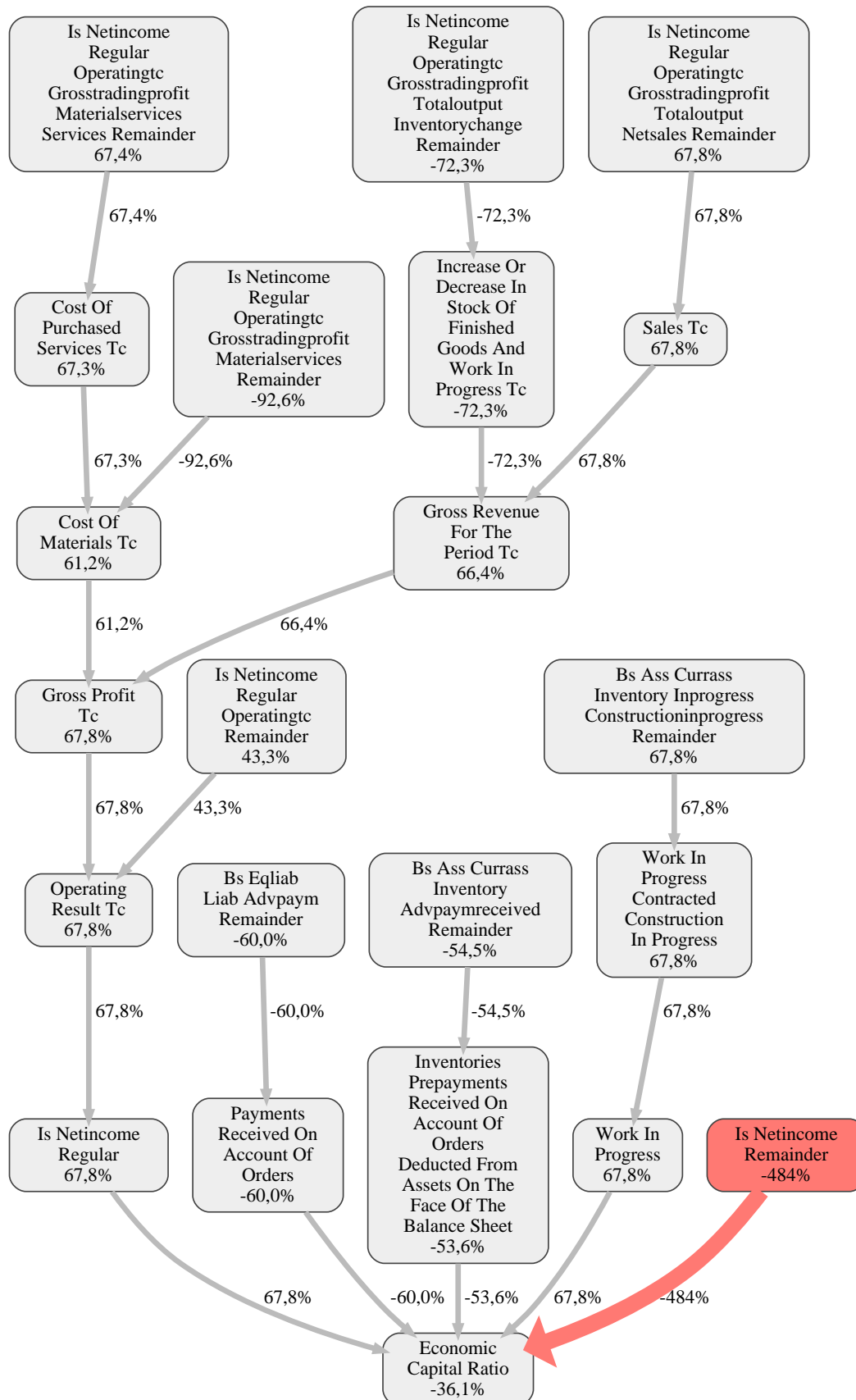

The greatest strength of Bauunternehmung Hofschröder GmbH Co KG compared to the market average is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Remainder, increasing the Economic Capital Ratio by 68% points. The greatest weakness of Bauunternehmung Hofschröder GmbH Co KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 484% points.

The company's Economic Capital Ratio, given in the ranking table, is 68%, being 36% points below the market average of 104%.
