



The relative strengths and weaknesses of Bauunternehmung Glöckle Hoch und Tiefbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Glöckle Hoch und Tiefbau GmbH compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 121% points. The greatest weakness of Bauunternehmung Glöckle Hoch und Tiefbau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 945% points.

The company's Economic Capital Ratio, given in the ranking table, is 121%, being 18% points above the market average of 104%.
