

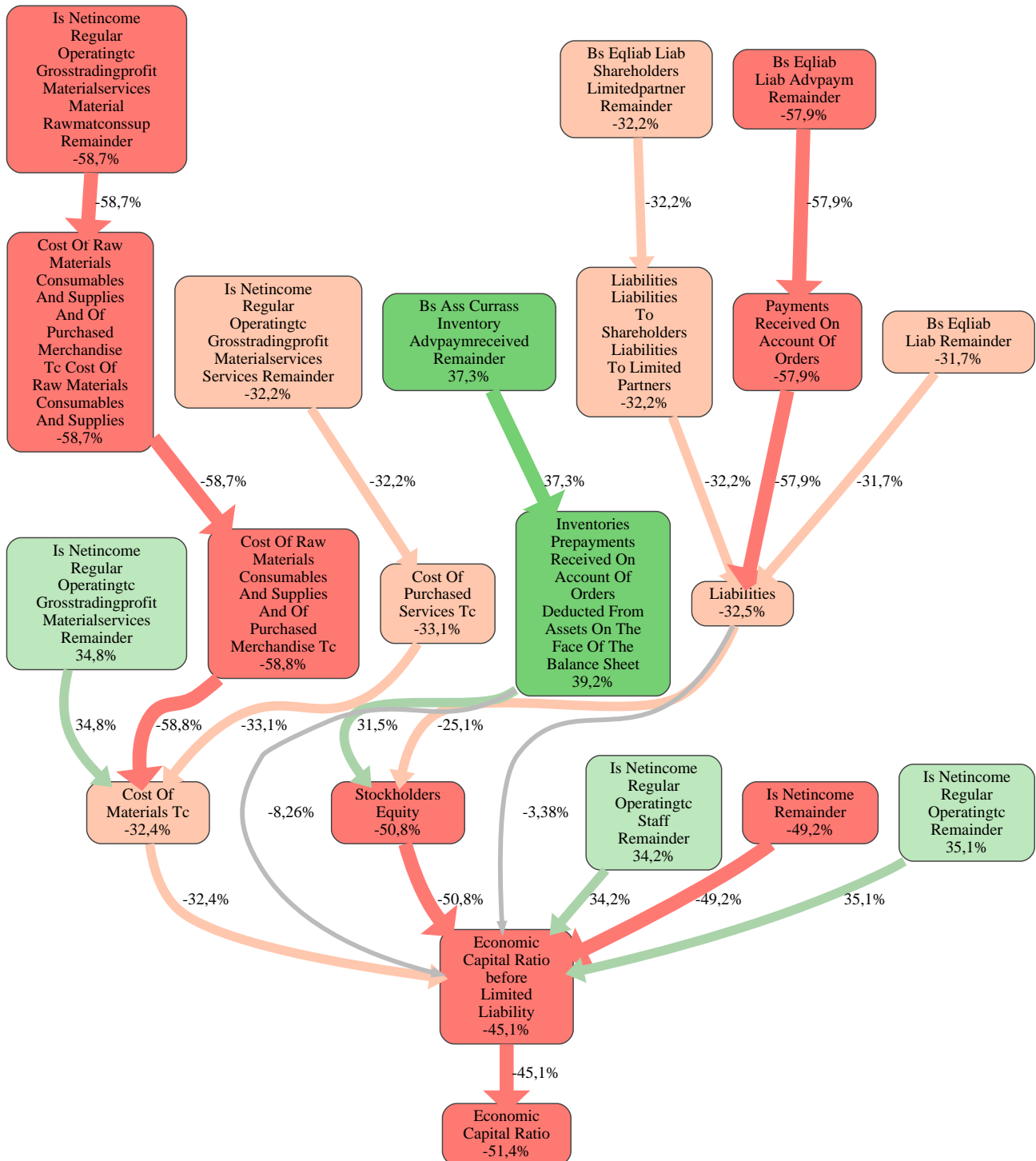

The relative strengths and weaknesses of Josef Fuchs Bauunternehmen GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Fuchs Bauunternehmen GmbH Co KG compared to the market average is the variable Inventories Prepayments Received On Account Of Orders Deducted From Assets On The Face Of The Balance Sheet, increasing the Economic Capital Ratio by 39% points. The greatest weakness of Josef Fuchs Bauunternehmen GmbH Co KG is the variable Cost Of Raw Materials Consumables And Supplies And Of Purchased Merchandise Tc, reducing the Economic Capital Ratio by 59% points.

The company's Economic Capital Ratio, given in the ranking table, is 52%, being 51% points below the market average of 104%.
