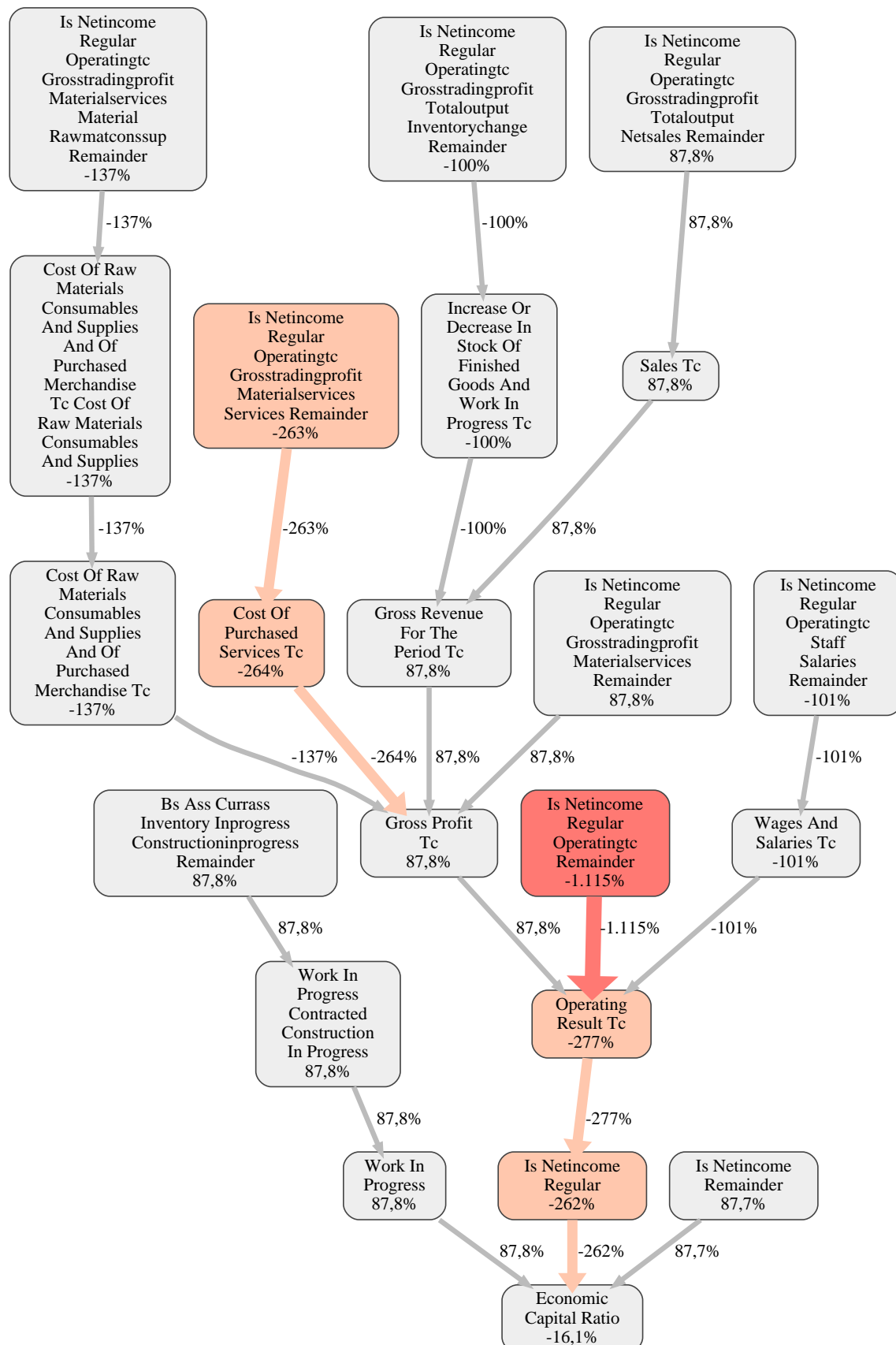

The greatest strength of Swietelsky Baugesellschaft m b H compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 88% points. The greatest weakness of Swietelsky Baugesellschaft m b H is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 1.115% points.

The company's Economic Capital Ratio, given in the ranking table, is 88%, being 16% points below the market average of 104%.
