



## Finsterwalder Bau Union GmbH Sitz Zeckerin Rank 64 of 381

The relative strengths and weaknesses of Finsterwalder Bau Union GmbH Sitz Zeckerin are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Finsterwalder Bau Union GmbH Sitz Zeckerin compared to the market average is the variable Bs Ass Currass Inventory Inprogress Remainder, increasing the Economic Capital Ratio by 152% points. The greatest weakness of Finsterwalder Bau Union GmbH Sitz Zeckerin is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 406% points.

The company's Economic Capital Ratio, given in the ranking table, is 152%, being 49% points above the market average of 104%.
