



The relative strengths and weaknesses of TIME Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of TIME Bau GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 62% points. The greatest weakness of TIME Bau GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 299% points.

The company's Economic Capital Ratio, given in the ranking table, is 62%, being 41% points below the market average of 104%.
