



The relative strengths and weaknesses of Tempel Bau Nord GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Tempel Bau Nord GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Remainder, increasing the Economic Capital Ratio by 95% points. The greatest weakness of Tempel Bau Nord GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 3.195% points.

The company's Economic Capital Ratio, given in the ranking table, is 95%, being 9,1% points below the market average of 104%.
