

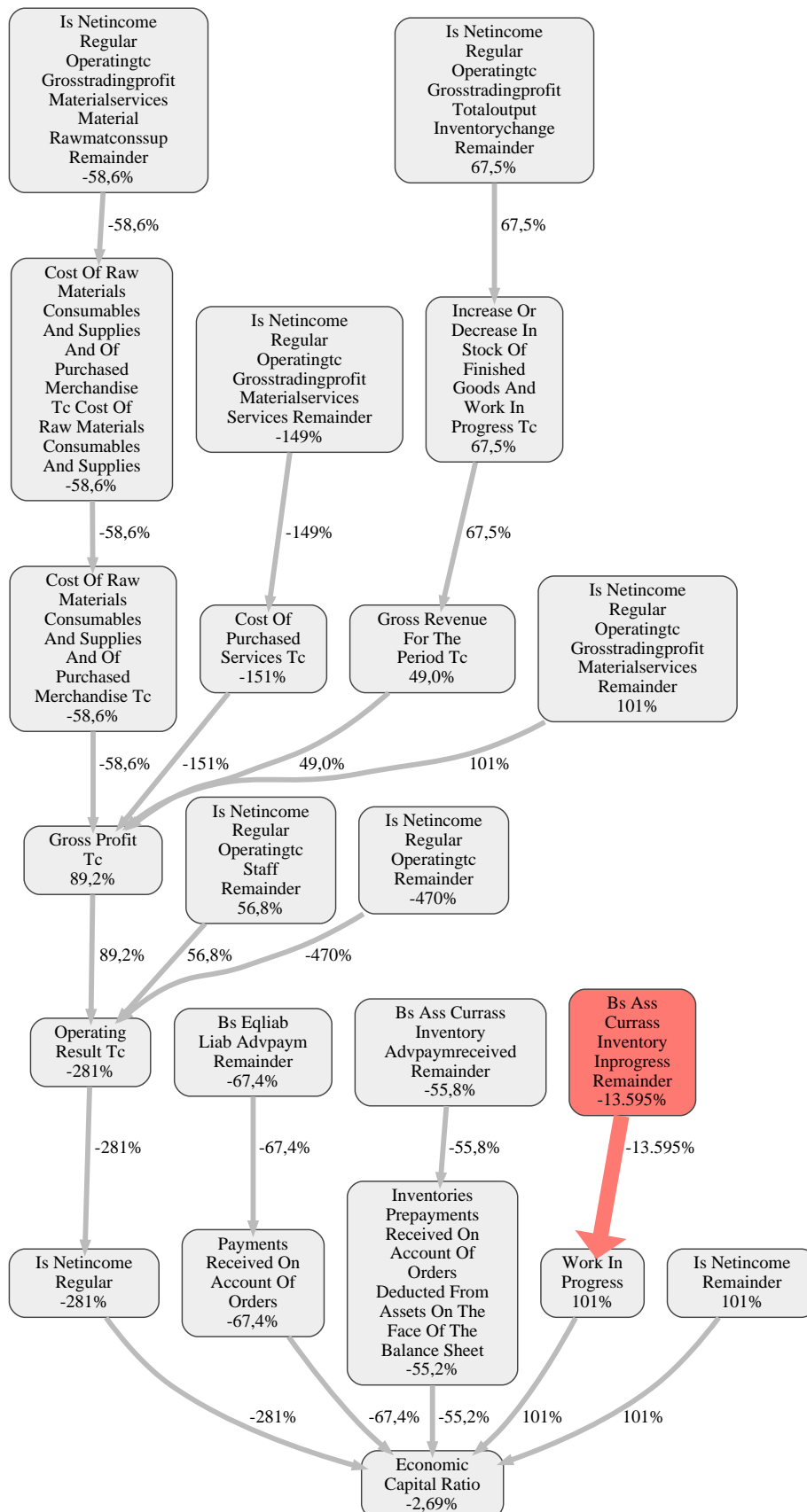

The relative strengths and weaknesses of Hentschke Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hentschke Bau GmbH compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 101% points. The greatest weakness of Hentschke Bau GmbH is the variable Bs Ass Currass Inventory Inprogress Remainder, reducing the Economic Capital Ratio by 13.595% points.

The company's Economic Capital Ratio, given in the ranking table, is 101%, being 2,7% points below the market average of 104%.
