



The relative strengths and weaknesses of Laudemann GmbH Bauunternehmen are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Laudemann GmbH Bauunternehmen compared to the market average is the variable Bs Ass Currass Inventory Inprogress Remainder, increasing the Economic Capital Ratio by 67% points. The greatest weakness of Laudemann GmbH Bauunternehmen is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 601% points.

The company's Economic Capital Ratio, given in the ranking table, is 67%, being 37% points below the market average of 104%.
