



The relative strengths and weaknesses of Wohnungsbau Gesellschaft mit Beschränkter Haftung für den Landkreis Augsburg are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau Gesellschaft mit Beschränkter Haftung für den Landkreis Augsburg compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 72% points. The greatest weakness of Wohnungsbau Gesellschaft mit Beschränkter Haftung für den Landkreis Augsburg is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 290% points.

The company's Economic Capital Ratio, given in the ranking table, is 72%, being 32% points below the market average of 104%.
