



The relative strengths and weaknesses of Freie Scholle Bau und Dienstleistungs GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Freie Scholle Bau und Dienstleistungs GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 177% points. The greatest weakness of Freie Scholle Bau und Dienstleistungs GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 310% points.

The company's Economic Capital Ratio, given in the ranking table, is 182%, being 78% points above the market average of 104%.
