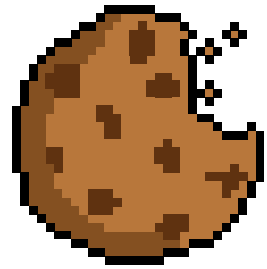
The company's Economic Capital Ratio, given in the ranking table, is 45%, being 59% points below the market average of 104%.
