



The relative strengths and weaknesses of Röhrsdorfer Wohnungsbauförderungsgesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Röhrsdorfer Wohnungsbauförderungsgesellschaft mbH compared to the market average is the variable Inventories Prepayments Received On Account Of Orders Deducted From Assets On The Face Of The Balance Sheet, increasing the Economic Capital Ratio by 22% points. The greatest weakness of Röhrsdorfer Wohnungsbauförderungsgesellschaft mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 195% points.

The company's Economic Capital Ratio, given in the ranking table, is 22%, being 81% points below the market average of 104%.
