



## Wohnungsbau und Verwaltungsgesellschaft Waldenburg mit Beschränkter Haftung

The relative strengths and weaknesses of Wohnungsbau und Verwaltungsgesellschaft Waldenburg mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau und Verwaltungsgesellschaft Waldenburg mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 123% points. The greatest weakness of Wohnungsbau und Verwaltungsgesellschaft Waldenburg mit Beschränkter Haftung is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 287% points.

The company's Economic Capital Ratio, given in the ranking table, is 124%, being 20% points above the market average of 104%.
