



The relative strengths and weaknesses of Wobak Städtische Wohnungsbaugesellschaft mbH Konstanz are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wobak Städtische Wohnungsbaugesellschaft mbH Konstanz compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 59% points. The greatest weakness of Wobak Städtische Wohnungsbaugesellschaft mbH Konstanz is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 283% points.

The company's Economic Capital Ratio, given in the ranking table, is 59%, being 44% points below the market average of 104%.
