

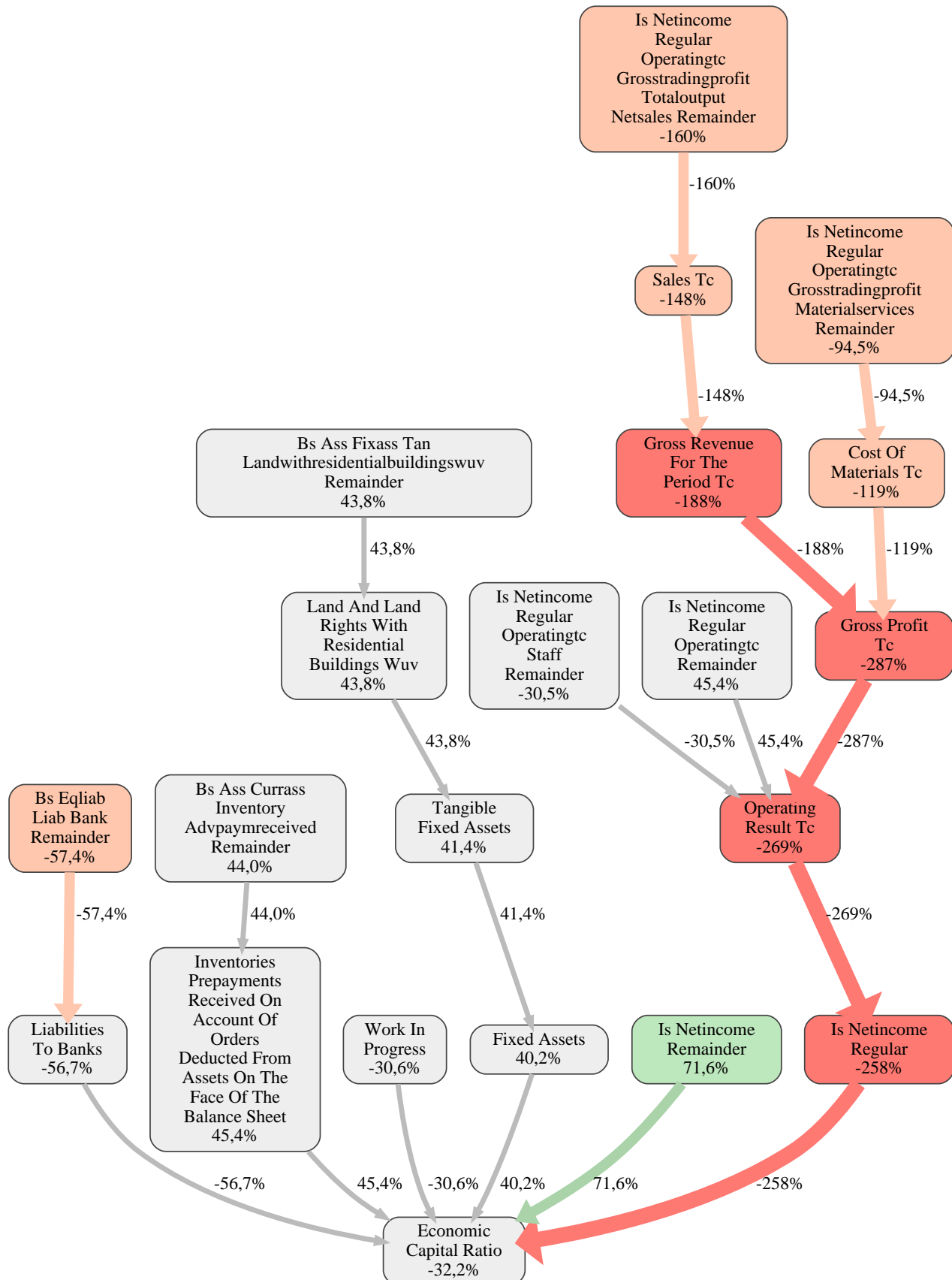

The relative strengths and weaknesses of Gesellschaft für Stadterneuerung und Stadtentwicklung Baden Baden mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gesellschaft für Stadterneuerung und Stadtentwicklung Baden Baden mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 72% points. The greatest weakness of Gesellschaft für Stadterneuerung und Stadtentwicklung Baden Baden mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 287% points.

The company's Economic Capital Ratio, given in the ranking table, is 72%, being 32% points below the market average of 104%.
