The relative strengths and weaknesses of Wobra Wohnungsbaugesellschaft der Stadt Brandenburg an der Havel mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wobra Wohnungsbaugesellschaft der Stadt Brandenburg an der Havel mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 69% points. The greatest weakness of Wobra Wohnungsbaugesellschaft der Stadt Brandenburg an der Havel mit Beschränkter Haftung is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 285% points.

The company's Economic Capital Ratio, given in the ranking table, is 69%, being 35% points below the market average of 104%.
