



The relative strengths and weaknesses of Wohnungsbaugesellschaft mbH der Stadt Barth are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft mbH der Stadt Barth compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 70% points. The greatest weakness of Wohnungsbaugesellschaft mbH der Stadt Barth is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 236% points.

The company's Economic Capital Ratio, given in the ranking table, is 71%, being 33% points below the market average of 104%.
